Tally Ho Equestrian Center Barn Rules

All persons, Boarders/Leasers/Students/Visitors, must agree to be in compliance with the following Barn Rules while on the premises of Tally Ho Equestrian Center:

Please help us to enforce these rules to keep the barn running smoothly and <u>safely</u>; for everyone's protection and enjoyment.

- 1. Safety helmets **must** be worn at all times while on a horse.
- 2. No smoking in or around the barn.
- 3. All persons handling or riding a horse must complete a waiver form, including <u>boarder's guests</u>. Boarders must also be present when allowing a guest to handle or ride their horse, unless prior arrangement has been made with me.
- 4. <u>Please clean up after yourself and horse!</u> Put all tack, equipment and horse away after use, sweep aisleway, washracks, etc..
- 5. Proper attire- No tank tops, crop tops or see thru clothing, no jeans in lesson saddles.
- 6. Please do not handle/feed horses (unless it's yours) without permission, as they may be on a special diet or strict handling program. You may bring treats for school horses, but please ask!
- 7. No horses are to leave the property without Tally Ho's knowledge/permission.
- 8. Riding lessons have priority over the riding rings, and we ask that you ride in a different area if you are not in a lesson, this will prevent overcrowding of riding rings. You must have someone with you to ride in the cross country field or trail for safety reasons.
- 9. Riders under the age of 12 are not to be left alone at the farm unless in a lesson or with prior special arrangements.
- 10. Only instructors approved by Tally Ho will be allowed to teach on the property.
- 11. No Jumping unless in a lesson or directed to by your instructor.

If any boarder, leasee, student, or visitor is negligent in complying with these rules they accept all responsibility for any and all personal or property damages incurred.

Riding Lesson Program Information

Tally Ho Equestrian Center would like to welcome and invite you to our new facility. The facility is spread out over 45 acres and includes a 200 x 250 ft. riding ring, a large jump field and a full sized dressage ring. Our barn has 30- 12 x 12 ft. stalls, utility room, feed room, lesson program tack room, 10 crossties and two hot/cold wash racks, a boarders tack room, lounge and two bathrooms. Tally Ho offers lessons, boarding, camps, horse sales and training.

Katrina Brown Hutto, the instructor and owner has many years of riding and teaching experience. She has an equine science degree from St. Andrews Presbyterian College and is a judge for schooling horse shows. She has specialized in Hunt Seat instruction. We horse show at 4 different levels: Schooling, "C" State Level, "A" National Level and National Middle and High School IEA Team.

Most lesson students begin in private ½ hour lessons at a rate of \$50 per lesson. The lessons will instruct the student in how to balance, steer and handle the horse while they progress at their own pace. When the student is confident and ready they will move into a group lesson where they ride with other students at their same riding level. Groups offer the students an opportunity to meet other fellow horse lovers and watch each other ride and learn together. When they progress to riding with three students in their group then the lessons automatically become an hour in length at the same rate of \$50 per student. As the student progresses he/she will do more and more of getting the horse ready for the lesson and putting him away when the lesson is over.

Students ride a minimum of one lesson per week and may reschedule for another time if a 24 hr. notice is given. For those previously experienced riders, they will progress at their own pace and from their current level. We also offer lessons to students 4 to 7 years old from our assistant instructors, Bree Taylor and Ashley Buchanan..

Lessons run as scheduled rain or shine, if we have poor weather then we head indoors and have a hands-on barn lesson. A barn lesson is a wonderful opportunity to learn more skills out of the saddle that the students will need if they hope to own their own horse one day, horse show or just learn more about their sport. They will learn a broad range of skills, such as: grooming, tacking, blanketing, feeding, getting ready for a horse show, medical care and how to put a horse on a trailer. This is where we also learn our skills for The Riding Academy and do our testing!

There are also camps which run throughout the year which offer a way to further a students horse experience or to expose a new or possible student to the world of horses. Please let us know if we can give you any further information or sign you up for lessons!

I understand that although I am signing this Agreement today, I intend for it to be valid and binding when I engage in any or all of The Activities at any time in the future and at any location. 2. Risks of Equine-Related Activities. I understand that anyone riding, driving, handling, working with, or even near an equine at any location can suffer bodily and other injuries. Among other things, equines are unpredictable by nature. For example, when frightened, angry, or under stress, the natural instincts of an equine are to jump forward or sideways, back up quickly, or run away from real or perceived danger by trotting or galloping. Equines also have the ability to kick, buck, rear up, spin around, strike, or bite. I know that equines can do these and other things without warning. I also understand that all equines, even if they have no history of hurting anyone, are powerful and have the potential to be dangerous to people, equines, and other animals. I also understand that riding, driving, handling, working with, or even being near an equine can expose me to numerous hazards, which could include, for example, those dangers or

conditions which are an integral part of equine activities, including, but not limited to: (a) the propensity of an equine to behave in ways that may result in injury, harm, or death to a person on or around the equine; (b) the unpredictability of an equine's reaction to sound, sudden movement, an unfamiliar object, a person, or another animal; (c) certain hazards such as surface and subsurface conditions; (d) collisions with other equines or objects; and (e) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, as failing to maintain control over the animal or not acting within the participant's ability. I understand these risks and dangers that are inherent in equine-related activities, and I agree to assume all of them. I also understand that these are just some of the risks, and I agree to assume others that are not mentioned in this Agreement.
